#### 5) New Business

Ms. Wilk- So I just want to remind everybody last year it's discussion, possible action exhaust bathroom from Buckingham Terrace. We discussed this last year. Everybody remembers, I just want to refresh. Remember we had a lot of mold and a lot of bathrooms at Buckingham Terrace and we had to install, we installed some fans. I thought we did install more, but we made a motion last year because it got to be so bad that we had to clean stuff up. We had to pay for dry cleaning and we opted to say we're going to install these exhaust vans to try and be proactive instead of reactive. It's coming to my attention that not all of them have been done. I know that we can just go for it, but it's a lot more than I thought. So, I'm just suggesting that we make a new motion to have exhaust bands be put into every unit at Buckingham Terrace on ones that are not there. Have all them done before it gets hot for these guys working in attics. And if we can have a motion for that to be done to avoid mold. The work is being done by PJ Electric. They're the ones that started it. So, we do have, I asked Lance to count because I really thought we only have seven left to do and we have a lot more than that. We have 32 left to do and so that's too high of a number. Even though we made the motion last year, I would rather cover us a little bit better just to make that motion again for those to actually be done and have all of them done and just, we'll let them know.

Bids were then opened for the paving and the sidewalks at Country Ridge. Envelope one was a certified letter that was not actually a bid. Envelope two was a bid for the sidewalk from C/S Paving for \$53,560 with processed stone at \$100/yd and \$18/ft of any additional sidewalk. Envelope three was also from C/S Paving reclaiming approximately 41,660 sq. ft. Option one is \$193,300 with \$1500 per basin. Option two is \$193,300 without the center island and again, with \$1500 per basin.

Because those are the only bids received, the Board will need to go back through the process and reach out to contractors they know to push in more bids. They will notify C/S Paving when the next round of bidding is.

#### 8) Resident Commissioner Report – Ms. Pratt

I don't have a report so much as it's in regard to hoarding problems that we have in our units. And at the last meeting, Dan had brought up something regarding people with pets doing more often inspections of the apartments. I am asking the commission that I think that in some cases that we have that there should be a list of people that quarterly have their apartments checked and others can go on a yearly list, so to speak. But I think it's out of control. And when Dan mentioned that about the, I think that to stop the problem that we're having, that it's something that I feel strongly about that we should be doing every three months or so.

Mr. Antonacci stated that he has had this happen in other properties and the best recourse is to have the Fire Marshall go out and do these inspections.

There should also be a policy in the RSC manual regarding wellness checks and the process of them and how to track them. There should also be well documented timing of them, either bi-monthly, quarterly or yearly. Because the Fire Marshall has the most authority here, they can go in and show how access points become a safety issue. If it happens again, there should be a strike policy, but they are the place to start with.

Ms. Pratt stated we need to begin this soon, as neighbors to the apartments in question are complaining and they have rights as well.
